Exit Right following the sign Green Bay I-41 North (3.8 miles). Exit Right following the sign CR BB/Prospect Avenue (Exit #136) (1.7 miles). Ramp forks, keep Left to CR-BB West (0.2 miles). Exit ramp (Left) at W. Prospect Avenue/CR-BB (100ft.) Turn Right on S. Casaloma Drive (0.6 miles). Turn Left on New Horizons Blvd (1000 ft.). Arrive at Fox Valley Animal Referral Center (300 ft)


